ANNOUNCEMENT FROM PRESIDENT HERBERT K. ZEARFOSS

On October 10, 2006, David Moltke-Hansen, President of The Historical Society of Pennsylvania and Herbert K. Zearfoss, President of The Genealogical Society of Pennsylvania signed a "Strategic Alliance Agreement" that had been previously approved by the Boards of both organizations following more than nine months of discussion and negotiation. The Agreement takes effect immediately, but its provisions will be implemented gradually over the next year and we will not be moving our offices to HSP's facility at 1300 Locust Street until sometime in mid-2007.

As soon as HSP has installed the necessary shelving we will begin transferring our collections of books and manuscripts to HSP. Any of our materials duplicated in HSP's collection will not be transferred, but will be deaccessioned either by sale or gift. And HSP's soon to be hired genealogical librarian will begin to process our manuscript collections (help from GSP volunteers will be needed for this project) so that they will be readily accessible to researchers.

When GSP members renew their membership on July 1, 2007, they will participate in a new membership program that includes many of the benefits of an HSP membership (such as access to the HSP research library) plus all of the benefits of the present GSP membership. There will also be a dual HSP/GSP membership available at a discounted rate for those who would like to receive all of the benefits of an HSP membership such as

the right to vote at HSP meetings.

GSP will continue its publication program of genealogical books and pamphlets as well as our *Pennsylvania Genealogical Magazine* which you receive with your GSP membership. *Penn in Hand* will be distributed to you as a part of the HSP newsletter *Sidelights*. Our Web site will be expanded to include additional research material in our "members only" area. We will, of course, continue our educational programming at our new location.

Returning to 1300 Locust Street is really like "going home." Our Society was formed in 1892 by members of HSP with the encouragement of the HSP Council and with the purpose of providing genealogical materials to HSP. Even for a time after our incorporation as a separate entity in 1920, membership in HSP was a requirement for membership in GSP. For the first 104 years of our existence we "lived" in HSP's building and built the "genealogical collection" that is housed in HSP's library. After more than ten years "on our own," it will be good to be home again.

We see real advantages to having our genealogical collections in a center city location under one roof and more available to our members. While we lack the financial resources to maintain a separate research facility, this move will reduce our operating costs which will allow us to save our resources to fulfill our mission of helping future generations of genealogists.

McCarty Genetic Genealogy and the Pennsylvania Wagon Road to South Carolina

McCarty descendants are using cutting-edge, "genetic genealogy" to find lost ancestors. The McCarty Edgefield South Carolina DNA Project is utilizing DNA testing to locate lost McCarty ancestors that settled in South Carolina in the 1700's. A simple swabbing of the inside cheek of the mouth is used to capture a DNA sample. The sample is then mailed to Family Tree DNA in Houston, Texas for testing. Robert McCarty, the project administrator is very pleased with their success thus far. He does believe however, that "absolute ancestral answers may depend on DNA testing in Pennsylvania and other migration points of origin." He theorizes that much family history was left behind, as these early pioneers set out to claim their new lands in South Carolina. The Pennsylvania Wagon Road may be littered with lost McCarty history that only DNA testing can recover. FROM THE EXECUTIVE DIRECTOR

Our busy Fall got rolling on Saturday 16 September with GSP's annual joint conference with the Chester County Historical Society. Unlike past Conferences, this one had only two speakers and no "tracks." Here from the United Kingdom were Paul Blake and Maggie Loughran, speaking on the genealogical resources in the UK – both archival and on the Internet. We enjoyed our largest attendance ever for this Conference — over one hundred — and evaluations informed us that those attending found the information conveyed very valuable.

September's final weekend found me in Pittsburgh at our joint Conference with the Western Pennsylvania Genealogical Society. When this conference was being planned we worried that we would not reach a registration of three hundred; the final tally of registrants was more than six hundred! Registrants from Alaska, Washington State, California, and every state in between, gave proof of

the heritage of all those Americans throughout the country whose ancestors settled in or passed through Pennsylvania. We're already being asked when the next conference on Pennsylvania genealogy will be.

Our farewell luncheon for Dottie Rodgers was held on 17 October. Sixteen of Dottie's friends and family joined her for lunch and wished her well in her retirement. GSP folks had a chance to meet two of her daughters and a sonin-law. A good time was had by all!
